The Court received your email inquiring about the status of ordering the transcript in a cross-appeal. On June 30, 2023, we issued an order dismissing the notice of appeal filed by Nathaniel Shell. As a result, the cross-appeal filed by Neil T. Phillips became the primary appeal.
