MOTION TO RECONSIDER

Undersigned Counsel hereby moves for reconsideration of this Court’s Order denying the Motion to Withdraw as counsel, issued on July 7, 2023.

Counsel respectfully requests this Court to reconsider given the complete breakdown of the attorney-client relationship. Since the Court’s Order, Mr. Dizzley sent a letter in which he made threats to “press criminal charges” and “go public with what you and the Court are doing, pursuant to these fraudulent acts [referring to the Court’s July 7, 2023 Order]”. Although Mr. Dizzley’s threats are utterly baseless, this latest letter further demonstrates the complete breakdown of the attorney-client relationship, and this is in addition to his history and pattern of behavior as described in the Motion to Withdraw and as demonstrated by his filings with this Court. Further,

in the past few months, Mr. Dizzley has insisted that Counsel proceed on frivolous courses of action, which Counsel finds repugnant and has a fundamental disagreement with.

Thus, Counsel respectfully submits that good cause exists to warrant withdrawal of counsel and respectfully requests that William G. Yarborough, Attorney at Law, LLC be removed as counsel for Appellant.

WHEREFORE Counsel respectfully moves this Court to vacate its July 7, 2023 Order denying the Motion to Withdraw as Counsel and to terminate William G. Yarborough, Attorney at Law, LLC as Appellant's Counsel of Record and be relieved from all obligations in representation in this matter.
