Dear Catherine:

We received report from the court reporter assigned Mrs. Shirley Gerral (attached) that a recording of arguments on October 13, 2020 either (a) were corrupt, or (b) did not record. I have asked effective yesterday that the court reporter confirm the computer IT for the Master in Equity court was able to recover, and if not we are prepared to proceed with filing of the Initial Brief with what we have of record.


I am asking by way of motion for an extension of 15 days so that the court reporter can check. Frankly, we expect the proceedings were inadvertently not recorded. 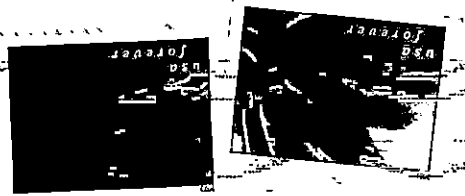
