" Grounds For Appeal "

ALC #
23-ALS-04-D150-ES

① The ALC completely failed to consider Appellant's evidence showing that he did mail SCOC a copy of NOA.

Appellant mailed an Affidavit stating that he deposited NOA in prison legal and mailed a SCOC Form 10-14 showing NOA was mailed to SCOC and Appellant charged U.S. postal fee for mailing legal mail. Finally, Appellant Crockett mailed ALC Judge Lenski original contemporaneous notes showing NOA mailed to SCOC.

Conspicuously absent from ALC Judge Lenski's order of dismissal is any mention of the foregoing evidence mailed to Judge Lenski. Consequently, Judge Lenski's order is erroneous.
