
Ruthless attacks on what little is left of Dr. Faltas' health and property continued with senseless and by-now-indecent demands that she file by paper (instead of by e-mail or electronically) and thus have to ambulate in this heat by non-extensible dates in *other* courts. That exhausts her physically, emotionally, and financially, and makes her feel besieged by *figurative* cannibals, idiot cannibals unaware that eating one's own species causes auto-immunity and death of the soul. 
WHEREFORE, the 60-day extension should be granted as hereby sincerely sought on 10 August 2023.
