

The Appellant pled guilty to Burglary (Violent) Second Degree (Indictment No. 2022-GS-46-1455) for a sentence of 15 years upon service of 3 years suspended on 5 years probation; and Domestic Violence First Degree (Indictment No. 2023-GS-46-1456) for a sentence of 10 years upon service of 3 years suspended on 5 years probation. The Appellant received 518 days credit for time served and both sentences to run concurrent. Also the Appellant pled to Stalking (Indictment No. 2022-GS-46-1457) and Malicious Injury to Animals, Personal Property, Injury Value \$10,000 or more (Indictment No. 2022-GS-46-1458) for a sentence of Time Served on both of them.



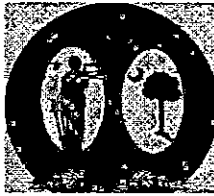

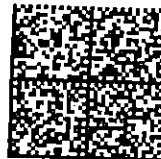
