I am the above appellatant for the above captioned case and I am asking that my case be put on hold or extention because of The above plaintiff's incarceration status.

I was arrested on July 3rd and is currently being held at the Florence county detention center awaiting trial.

due to this unexpected incarceration the plaintiff has lost his ability to access his records to the above case. The plaintiff called the court of Appeals to inform them of this incarceration on Friday July 8th 2023 and Monday July 11th 2023 and was advised to ask the courts to ~~put~~ Put this case on hold until the plaintiff's release, or for an extention of time so the case wont be dismissed.

So the plaintiff hereby ask the courts for an extention of time to file initial Brief and Record on Appeal and Final brief in a manner that the Courts of Appeals see fit.

My original document are in a Uhoual storage due to Plaintiff homelessness and plaintiff have no Family Support to aid him. So I will need an extention of time to recover all lost documents so that I can re-prepare my record on Appeal and Final Brief.

Also I will like to bring to the Courts attention that I Filed and served initial Brief before giving deadline of June 26th but after speaking with clerks at the Court of Appeals the Clerks said they never recieved my initial Brief I will like to ask the courts not to dismiss my case due to this error. Because I did send in my initial Brief. You can ask my Case Manager MS. Katelyn. She will verify that I did file initial Brief. Some kind of Mistake has happened

and I dont know how. So im asking the courts to please ~~extend~~ For an extention due to this error. The clerk said my inial Brief is due July 10th 2023 but this is an error because I ordered the transcript in May 2023 and was given a deadline on June 26 2023 to file initial Brief. and I sent my initial Brief in before this date. Now the Courts said they dont have it and my deadline is on July 10th 2023. this has to be a error on the courts part.

Today is July 11th and I was advised by Clerks at the Court of Appeal to file for an extention of time to submitt all records needed so that my case wont be dismissed. so I'm asking the courts for an extention of time to file all documents, so my case wont be dismissed due to this error.
