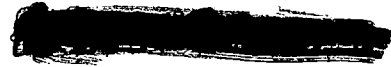

Hey Lindsay –

Sorry, I ended up home yesterday afternoon and this morning with a sick kid and was trying to get ready for court this afternoon. Came in to the office just before court started. Just now getting out of that.

I think I'm probably at a cap of 5 being the best I can do. USC is really put out with him, and the cap of 5 offer he had was prior to getting all the new charges, so I'd be looking at doing the original grand larceny, one of the petit larceny enhancements, and a trespassing with the intention of telling the judge we believe some active time is appropriate but are recommending it be with a cap of 5 years. If you want to ask for 2 years, I'm not going to argue against it and don't really have a problem with it being 2 years, but I've had USC asking about this case since I've had it and that professor was pretty devastated at the loss of her computer, as it apparently had a lot of research and writings and stuff that all the restitution in the world won't get back for her. I know it's late, so if we just need to do the BW motion, that's fine. LE just asked that we ask for an ankle monitor as a new condition of bond if the judge does vacate the BW. Feel free to call my cell if you want to talk more.
