Personally appeared before me the affiant Christine J Snyder who being duly sworn deposes and says that defendant Audrey Alexandra Wright did within this county and state on or about 6/30/2021 violate the criminal laws of the State of South Carolina (or ordinance of County/ Municipality of Horry)

On the following particulars:

DESCRIPTION OF OFFENSE: Drugs / Trafficking in Heroin, morph., etc., 4 g or more, but less than 14 g - 1st offense

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On 30 June 2021, at approx. 2:46PM, a Home Detention Program Residential Compliance Check was conducted at 13797 Cape Landing Circle Unit K, in the Myrtle Beach area of Horry County, SC. During this time, defendant Wright was found to knowingly and intentionally be in possession of eighty one (81) round, blue tablets, with the imprint "M & 30." At this time Wright stated that the tablets were fake and not the prescribed drug/controlled substance identified as Oxycodone 30mg. A presumptive drug test was subsequently conducted by the Horry County Drug Lab, which indicated the tablets to be the illicit substance Fentanyl (total approximate weight 7.8 grams), which exceeds the prosecutorial threshold to indicate Trafficking in narcotic drugs.
