



CRIMINAL SEXUAL CONDUCT WITH A MINOR, THIRD DEGREE

That in Charleston County, South Carolina, between October 1, 2013 and November 11, 2013, the defendant, Stanley Miller, date of birth _____, who was over fourteen (14) years of age, did wilfully and lewdly commit or attempt to commit a lewd or lascivious act upon or with the body, or its parts, of _____, date of birth _____, a child under sixteen years of age, with the intent of arousing, appealing to, or gratifying the lust, passions, or sexual desires of the defendant or the child. That, in addition, if the defendant was 18 years of age or less and the child victim was at least 14 years of age, said lewd or lascivious conduct was non-consensual; in violation of Section 16-3-655(C), South Carolina Code of Laws (1976) as amended.




