RESTORE APPEAL



The Court should affirm its Order filed June 21, 2013, dismissing this appeal for the reasons stated below.

The Appellant must make satisfactory arrangements in writing with the court reporter for furnishing the trial transcript within ten (10) days of the date of service of the notice of appeal for an appeal from the Court of Common Pleas. Rule 207(a)(1), SCACR. The Appellant's Certificate of Mailing reflects that the notice of appeal was served on May 3, 2013. The correspondence provided by the Appellant shows it did not make satisfactory arrangements in writing with the court reporter to furnish the trial transcript until May 22, 2013. The Appellant, therefore, did not comply with the ten-day requirement of Rule 207 for ordering the transcript. The Appellant also failed to

contemporaneously furnish opposing counsel with copies of all correspondence as required by Rule 207. Rule 207(a)(1).

The Court should therefore deny the Appellant's Motion to Restore Appeal.




