
INDICTMENT

At a Court of General Sessions, convened on November 18, 2021, the Grand Jurors of York County present upon their oath:

**HOMICIDE BY CHILD ABUSE**

Stacy Michelle Rabon did, on or about August 12, 1992, in York County, South Carolina, commit the crime of Homicide by Child Abuse in that the Defendant (1) did cause the death of a child who was under the age of eleven while committing child abuse or neglect as defined in Section 20-7-490 (recodified as Section 63-7-20), and the death occurred under circumstances manifesting an extreme indifference to human life, or (2) did knowingly aid or abet another person to commit child abuse or neglect as defined in Section 20-7-490 (recodified as 63-7-20) and the child abuse or neglect resulted in the death of a child under the age of eleven, all in violation of 16-03-0085, *Code of Laws of South Carolina* (1976), as amended.

Against the peace and dignity of the State, and contrary to the statute in such case made and provided.
