

Relationship stated on July 22, 2019, that the Appellant, "could not return to work, "According to *SC section code* § 42-9-170 and *SC section code* § 42-15-60 (A) the Appellant was entitled to continue receiving TTD payments while receiving Disability Benefits and continued receiving, while still under the Appeals process. The Appellant stopped receiving funds since 11/30/2018. In addition, the Respondent failed to report that the Appellant refused the settlement payment in the amount of \$3,012.25. Opposing Counsel J. South Lewis II; admitted after the December 19, 2022 Judicial Review that he had possession of the check of \$3,012.25. If the Court of Appeals would review all records from SCWCC; it would show that the Appellant's Civil Rights to Due Process has been violated throughout the commencement of the case, as in Supreme Court Case, *Paula Russell v. Wal-Mart Stores, Inc. Appellate Case No., 2018-00035*; Ms. Paula Russell, Appellant reported a change of condition claim to a single commissioner for what would be a third ruling on the same claim. Russell appealed the remand order to the courts of appeals, which dismissed the appeal on the grounds the order was not a final decision, and thus not immediately appealable, but after some time the SC Carolina Supreme Court found the remand order was immediately appealable because the commissioner's unwarranted delay in making a final decision required immediate review to avoid leaving Russell adequate remedy on an appeal from a final decision. The Court reversed the Court of Appeals' order dismissing the appeal, reversed the appellate panel's remand order, and remanded to any appellate panel of the commission for an immediate and final review of the original commissioner's decision. In this case, the decision to accept the claim October 5, 2018, without undisputed. The Appellate suffered more injuries as a result of the Medical Care receive on 04/12/2019, when an Unauthorized PA from Carolina Orthopaedic Neurological Associates; PA, William Sean Irving removed the Appellants neck brace. On the same day, he and Dr. David Mitchell noted that they notice "At this point, we feel that her wearing the neck collar is making her neck weaker. And then 06/19/2019 when Dr. Terazella attempted an EMG Study. These injuries were reported in a timely manner. But the Commissioners failed to address the injuries once they evolved to Occupational Diseases as t leaving the Appellant Permanently Disabled. The Commission failed to allow the Appellant ON RECORD to fully litigate her injuries. The Appellant never litigating the injuries and Occupational Diseases incurred by Builders First and Liberty Mutual Physicians, under SC Section code § 42-1-160(A)(B)(1)(C)(1).

The Appellate would like to notably mention; *SC Section code* §42-1-415 Representation of Coverage; reimbursement from Uninsured Employer's Fund (C) The knowing and willful falsifying of information contained in standard forms submitted pursuant to this section must consider fraud and subjects the person responsible for filing the false documentation to the penalties for fraud as provided by law. Atty. Amanda Neely and Atty. Mary Kate Littlejohn submitted false documentation and submitted them on to the SCWCC and it was accepted to public record. Likened to the matter of Mark E. Schnee/Appellate In the Supreme Court; Case No.: 2018-001473 and 2020-000850. First, Atty. Neely submitted evidence for the September 16, 2020, hearing that violated SC Coded 17-28-350 altering and tampering with evidence and Commissioner T. Scott served as attorney for Liberty Mutual during the commencement of the hearing. Then, without notice Mary-Kate Littlejohn submitted tampered evidence to have the Appellant's Motion for Reinstatement dismissed. And like Ms. Russell in Russell vs. Walmart Case No.:2018-

00035, there is a similar connection in that the “commission’s unwarranted delay in making a final decision required immediate review to avoid leaving Russell with no adequate remedy on an appeal from a final decision. “In this current case, the Appellant received an Appeal Decision that was sometime around February 24, 2021, leaving the Appellant with no recourse to file for relief. This was reported to Executive Director, Gary Canon, his reply, “The Order you received denying your Motion for Reinstatement is the only document issued by the Commission in this matter.” The Appellant received a decision of Denial. But was not give Just Cause to file an Appeal and then Atty. Amanda Neely perjured herself before the Court of Appeals on September 15, 2021, when she stated that she was not properly Process Served, while she was out on Maturity Leave. The Appellant made copies of a settlement check (that was returned to Atty. South Lewis II) the check presented in “C/O Mary Kate Littlejohn” and in February of 2022 it was changed to Atty Amanda Neely demonstrating that Atty Mary-Kate Littlejohn just prior to the Court Appeals September 15 decision; she was the only one representing the interest of Liberty Mutual and Builders First source. The Appellant submitted it to the Court of Appeals, but the Appellant was informed that decision must be Appealed before the Supreme Court. Through a Remittitur, the case was returned from the Supreme Court to SC Workers Compensation Commission. The Appellant filed a Form 50 and paid the fees to allow for oral litigation of all Occupational Diseases. Again, Atty Neely submitted evidence that was altered, and tampered with and Commissioner Michael Campbell allowed the evidence onto record attempted to Dismissed the Appellant’s case, but Form 50 was filed before the Decision. And then a Pre-hearing was conducted OFF RECORD, the settlement check was handed to Commissioner Gene McGaskill, and he returned it to Atty. South Lewis II. Atty. Neely and Atty. Littlejohn were not present for the hearing and are no longer representing the interests of Liberty Mutual and Builders First Source. The Opposing Counsel’s position should have been dismissed on the account of (1) multiple times submitting evidence that reported and shown as being tampered with; by the previous Attorneys caused irreparable harm to the Appellant; which should have made each Commissioners Orders Null/Void. (2) Atty. South Lewis II testimony should not be allowed accepted on to record, since everything he utters; would be deemed as “HEARSAY” and should be stricken from the record. But on May 28, 2023, a Pre-hearing was conducted OFF THE RECORD AND ORDER WAS RENDERED OFF THE RECORD. Under SC Rule of Civile Procedure 58(a) “A judgment is effective only when so set forth and enter in the record.” Under SC Rule of Civil Procedure 60 (b) (3)(4) In addition, “Motion and upon such terms as are just, the court may relieve a party or his legal representative from a final judgement, **order**, or proceeding for the following reasons: fraud, misrepresentation, or other misconduct of an adverse party;” ..., “the judgment is void.” That decision was by the One Commissioner on August 3, 2022, and then on August 8, 2023, Commissioner Avery Wilkerson enters the same Order, to prevent Opposing Counsel from falling in DEFAULT Judgement for not responding to Appellant’s Motion for DEFAULT Judgment. On August 8, 2023, the was no hearing, but he stated the case came before him, but no one was present. Which should have made the judgement VOID as well. But it was allowed in to Record and stayed. The Appellant requested a Judicial review to Review the Procedures of the Commissioners to have all rendered decision on Case Id: 1815744 and all of the Commissioners procedures reviewed. One of the Commissioners that allowed tampered/altered evidence on February 24, 2021,

was now allowed to conduct the Judicial Review. Commissioner T. Beck, prior to the Judicial Review voted to have the SSA-1709 A forms excluded being allowed ON RECORD for the Judicial Review.

The Appellant wishes to add *SC Section code §42-1-620* Agreement or regulation does not limit liability of employer. No contract or agreement, written, or implied, and no rule, regulation or other device shall in any manner operate to relieve any employer, in whole or in part, of any obligation created by title. According to *SC Sec. code §42-15-70* Liability of Employer for medical treatment; effect of malpractice. The Appellant suffered from 3 separate injuries at the hands of the physicians and is left with 5 different Occupational diseases. The Appellant reported the worsening of her condition to no avail. Provided Medical documentation of all diseases. And was able to have all the diseases diagnosed with the authorized Treating Physicians refused to so after afflicting injuries. The Commissioners knew the Appellant's condition and still failed to fulfill its responsibilities under the Workers Compensation Act to promptly decide this case without prolonging litigation. The Appellant as of October 2022 has finally become approved for SSD benefits. But if the Appellant is entitled to benefits, most recently that means she was entitled to receive them for many years. *S. C. Prop. & Cas. Ins. Guar. Ass'n 411 S.C.* According to the statute the Appellant wishes to recover Economic as well as Non-economic damages based on the South Carolina and Fiscal Affairs Office's May 2023 terms.

The commission's unreasonable delays and denials to accept responsibility of claim that was already accepted. The Appellant request Motion be granted under Rule 37(a) Motion for an Order Compelling Disclosure or Discovery of all evidence concerning the \$80,000 that was reported to SSA from South Carolina Workers' Compensation Commission. This has left Appellant without an adequate remedy on appeals and from a final decision under SC code section §1-23-380. Therefore, the Appellant asks for relief by **REVERSE**, the Court of Appeals June 15, 2023, decision for Dismissal. **REVERSE** the order Panel of Commissioners decision dated February 14, 2023. **REMAND** to any appellate panel for immediate and final review of the original approval from the Commission dated October 5, 2018, reimburse the Appellant all TTD benefits dated back to 11/30/2020 till present. And lastly allow the Appellant's 14th Amendment Civil Rights to Due Process to conduct a fair hearing ON THE RECORD to allow the Appellant to litigate the full extent of her injuries in order to receive full compensation as detail under the South Carolina Revenue and Fiscal Affairs Office for the May 2023 term.
