
PETITIONER'S RETURN TO MOTION TO CORRECT CAPTION

Upon filing the Petitioner's Writ of Certiorari, counsel for the Petitioner received a phone call from the clerk at the Supreme Court. Counsel for the Petitioner was directed to change the caption and instructed exactly how the caption should read. Counsel for the Petitioner was advised the Writ would not be entered as filed until the correction was made. 
