Zy'Tawn Kenias Childs appeals the sentence received as a result of his guilty plea on February 27, 2023. The sentence was imposed by the Honorable Eugene C. Griffith, Jr. on February 27, 2023. Mr. Childs filed an appeal on his own behalf on March 8, 2023. On March 9, 2023, a letter was sent to Counsel for the Defendant from the South Carolina Court of Appeals noting the deficiencies in the appeal.

Counsel for the Defendant filed a Motion to be Relieved since Appellant filed the appeal on his own without speaking to counsel and that Appellants family had told Counsel for the Defendant that private counsel had been retained. Counsel for the Defendant was not relieved.

The appellant further applied for indigent appellate defense for his appeal, but his application was missing information needed.

A letter was sent to Counsel for the Defendant on August 24, 2023, directing Counsel to cure the deficiencies outlined in the Marh 9, 2023 letter.


