To whom it may concern,

I have been trying to reach the Clerk of Court of Appeals for almost two weeks by telephone. I've left several messages, but no one ever returned my calls. It's of great importance that someone contacts me.

On Friday, May 19, 2023, a woman came onto our property claiming she just bought our house. We explained to her that we were in appeals and showed her our letter of approval of the appeal. She left but called us the next week harassing us over our case. She proceeded by sending a man to our home telling him to go inside our home to take pictures and give repair prices. I was able to stop him from proceeding, but she had already put our home up for sale on Facebook Marketplace with pictures of my children in them. She ended up selling her Quit Claim Deed to another woman. The first time (Friday, July 14, 2023) this other woman came onto our property, she refused to leave; threatening us by saying that my wife and I were going to jail and our children were going to DSS. The police came and told her they were aware of our home being in appeals court and told her not to return. On July 16, 2023, around 11:00 PM, she showed up with two men in two trucks. They tried breaking our gate lock, but then jumped our gate and proceeded sneaking up our driveway. I called 911, I hollered at them that the police were on their way and they took off. On July 25, 2023, she showed up on our property again. She was video recording us and our children. She threatened my wife with a Taser gun. She was charged for this and was placed on "no trespass". Since then, she made claims of coming onto our property and planting a flower. On Sunday, August 20, 2023, my wife saw a man walk past the window. She had sent her boyfriend and another man out to our home. They jumped our gate and again we called the police. After confronting them, they fled before the police showed up. This is just a summary of what we have been going through. Because of all these invasions of privacy, trespassing, harassing and threatening us, we have been under great distress. Our children are having nightmares. My wife and I jump at every sound we hear. We're barely able to sleep; we're suffering from mental exhaustion and our health is going down due to these traumatic actions. There is an ongoing police report. We feel that our lives are in danger due to the hostile actions of this woman. These people would've never shown up in our lives if the Respondent had not sold his Quit Claim Deed. No American should ever have to go through something like this, especially when we were never served due process to begin with.

I am requesting an extension. We have been diverted from being able to work on our case, due to the careless actions of the Respondent, by selling a home that is in dispute in the court system.
