

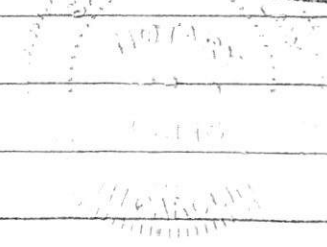



ON THE ABOVE DATE AND TIME, R/O OFFICER WAS DISPATCHED TO THE ABOVE LOCATION, WITHIN THE CITY LIMITS OF GAFFNEY, IN REFERENCE TO A MAN WITH A GUN. WHILE IN ROUTE, CHEROKEE COUNTY DISPATCH INFORMED R/O SHOTS WERE BEING FIRED. UPON ARRIVAL, I, OFFICER MABRY, PULLED AROUND BACK OF HAROLD'S RESTAURANT, AND OBSERVED A WHITE MALE WITH A GUN. I, OFFICER MABRY, GAVE COMMANDS FOR THE MAN TO PUT THE GUN DOWN AND THE MAN PUT THE GUN DOWN AND WAS STATING HE WAS SHOT. I, OFFICER MABRY, SECURED THE WEAPON AND PUT IT IN MY VEHICLE. I WENT BACK TO THE MAN THAT HAD TO GUN AND HAD STATED HE WAS SHOT, HE WAS LAYING ON THE GROUND HOLDING HIS STOMACH AND CHEST. R/O ASKED HIM WHAT HIS NAME WAS AND HE STATED HIS NAME WAS TONY LIPSCOMB, THE OWNER OF HAROLD'S. R/O ADVISED DISPATCH I HAD 1 GUN SHOT VICTIM WITH A GUN SHOT IN THE CHEST AND ABDOMEN AREA AND I, OFFICER MABRY, HAD ALSO SECURED A HANDGUN. OFFICER HAMPTON CAME OVER AND BEGAN TO APPLY PRESSURE TO THE CHEST GUN SHOT WOUND ON TONY LIPSCOMB. I, OFFICER MABRY, WAS BEING TOLD THERE WAS ALSO ANOTHER GUN SHOT VICTIM AT THE OTHER END OF THE PARKING LOT SO, I WENT TO CHECK ON A WHITE MALE. ONCE SPEAKING TO THIS MAN, HE IDENTIFIED HIMSELF AS BRANDON RAMSEY. MR. RAMSEY HAD HIS LEFT SIDE OF HIS PANTS PULLED DOWN AND A GUN SHOT ON THE UPPER LEFT LEG. EMS ARRIVED ON SCENE AND BEGAN TO EXAM MR. RAMSEY AND TRANSPORTED HIM TO THE HOSPITAL. I, OFFICER MABRY, BEGAN TO SPEAK WITH WITNESSES THAT STATED THEY WERE PRESENT AT THE SCENE. I SPOKE TO CHARLES HUSKEY AND HE WAS WILLING TO PROVIDE A STATEMENT BUT COULD NOT WRITE A STATEMENT DUE TO HIM STATING HIS LITERACY LEVEL WASN'T GOOD. I, OFFICER MABRY, TOLD MR. CHARLES HUSKEY, I COULD WRITE WHAT THE STATEMENT FOR HIM IN HIS WORDS, THEN HE COULD SIGN THE STATEMENT WITH THE NOTATION ON THE STATEMENT AS TO WHY I WROTE HIS STATEMENT. SGT. CODY TURNER SPOKE TO KATHY CALVERT AND CHRISTOPHER BURNETT, WHOM STATED THEY WOULD WRITE A STATEMENT, ALSO.

CHARLES HUSKEY STATED TO R/O, TONY LIPSCOMB, (HAROLD'S OWNER) ASKED THE SUBJECT TO LEAVE THE RESTAURANT AND THE SUBJECT TRIED TO BARGAIN WITH TONY SO HE WOULDN'T HAVE TO LEAVE. TONY ASKED THE SUBJECT TO LEAVE AGAIN AND THE MAN LEFT. THEN, THE SUBJECT CAME BACK INSIDE A FEW MOMENTS LATER WITH A GUN IN HIS HAND. THE SUBJECT STATED TO VICTIM WHOM WAS WEARING A NEON GREEN SHIFT, LATER IDENTIFIED AS BRANDON RAMSEY, "WHAT DID YOU SAY ABOUT ME?" VICTIM (BRANDON RAMSEY) STATED "I AIN'T SAID NOTHING TO YOU." CHARLES HUSKEY STATED THAT WAS WHEN HE LEFT AND HE HEARD GUN SHOTS INSIDE. MR. HUSKEY STATED HE THEN LOOKED TOWARD THE FRONT OF THE BUILDING AND HE SAW VICTIM, BRANDON RAMSEY, COMING OUTSIDE. VICTIM, MR. RAMSEY, ASKED CHARLES HUSKEY IF HE COULD GO BACK INSIDE AND GET HIS COAT, AND MR. HUSKEY WENT BACK INSIDE AND GOT MR. RAMSEY'S COAT.
