

Counsel filed the initial brief of appellant and designation of matter in the case of State v. Michael Wilson Pearson on Tuesday, May 28, 2013. Counsel filed the brief of petitioner in the case of State v. Eric Dantzler on Monday, May 13, 2013. On Wednesday, May 8, 2013, counsel had an oral argument in the case of State v. Antwan McMillan. On Monday, May 6, 2013, counsel had an oral argument in the case of State v. Travell Hill. On Wednesday, May 1, 2013, counsel filed the Anders brief of appellant and record on appeal in the case of State v. Jacqueline Yvette Sullivan, and the petition for writ of certiorari and accompanying appendix in the case of Johnny Frazier v. 
4. As indicated by his consent below, counsel for the state graciously consents to or does not oppose this request.


