Justice was on Parole for 4 counts of Burglary 2nd Degree. He was paroled in March 2012. He maintained employment while he was being supervised and his last employer was where he ran into problems. Justice had managed to stay out of trouble until he began drinking excessively. He first got into a verbal altercation with his former employer and her son. His agent advised him that he was to have no contact with his former employer or anyone in her family. Two days later a physical altercation occurred in which two Assault and Battery 3rd Degree charges were filed on Justice. Justice's agent issued a warrant and he was arrested and an Administrative Hearing was held in which it was recommended that the case be forwarded to the Parole Board with a recommendation of revocation. Justice was revoked by the Parole Board on October 16, 2013 and his parole case was closed. -nc
