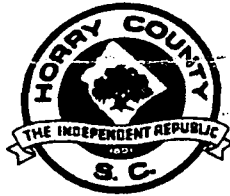

Once she has received your payment, the Court Reporter will transcribe the hearing and forward the official transcript to the Horry County Probate Court.


✓ In addition, an official transcript from the hearings held on August 9, 2010 and October 1, 2010 will also need to be obtained from Q&A Court Reporting, located at 709 W. Evans Street Florence, South Carolina, 843-673-9845. The Probate Court had forwarded the digital recordings/files of these hearings to Q&A Court Reporting and they have estimated the cost of transcribing the files is approximately \$220.00. You will need to contact Q&A to make appropriate arrangements for payment

of these transcript costs. Once payment has been received, Q&A will transcribe the hearings and forward the official transcripts to the Horry County Probate Court.

Upon receipt of the three (3) transcripts, the Probate Court will file the official transcripts with the appellate court so that they can be included as part of the record for your appeal of the Probate Court's Order in this estate dated July 19, 2011.
