



ORDER

Appellant has filed a motion to proceed *in forma pauperis*. The right to proceed *in forma pauperis* must rest upon a statute or a fundamental constitutional right. *Ex parte Martin*, 321 S.C. 533, 471 S.E.2d 134 (1995). Appellant has the burden of showing his entitlement to this relief, but he has not done so. Accordingly, Appellant's motion is denied.

Appellant has fifteen days from the filing date of this order to provide this Court with the \$250 notice of appeal filing fee. Failure to provide the filing fee will result in the dismissal of this appeal.
