Dear Adriane Burk Coordinator and Robert Dudek Attorney, SC Commission on Indigent Defense, Why did you order a trial transcript on 9/19/23 and wait SEVEN days to email me and tell me what you had done? Did you do that to attempt to obstruct justice by waiting long enough that is too late to cancel the request? On 9/14/23 which was the thirtieth day, I meter mailed a response to the SC Court of Appeals with an estimated delivery date of SATURDAY 9/16/23 and the SC Court of Appeals stamped it in on 9/18/23, meaning if you had checked my case online on 9/19/23 you would have seen my response. Not only did I respond to the SC Court of Appeals about my case being illegally hidden from the Richland County Public Defender's office by Jeanette McBride, the Richland County Clerk of Court but Judge Robert E. Hood, designated as Chief Judge for Administrative purposes for the 5th Circuit, Richland and Kershaw Counties, emailed me over the weekend that he would be trying my case at 2:00pm instead of the assigned Judge at 9:00am but I also requested an EXTENSION to order the trial transcript and I have requested a SLED investigation. The SC Department of Employment and Workforce LIED to eighteen-year veteran of law enforcement and now FORMER SLED agent James Flowers who was my arresting officer on 12/11/14.
