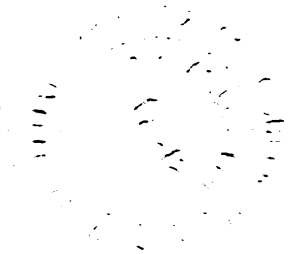

Personally appeared before me the affiant Jonathon D Bond being duly sworn deposes and says that defendant Aaron Lamar Caldwell did within this county and state on or about 5/23/2022 violate the criminal laws of the State of South Carolina (or ordinance of County/ Municipality of Aiken) in the following particulars.

DESCRIPTION OF OFFENSE: Resisting / Resisting Arrest; Oppose or resist law enforcement officer serving process or making arrest

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

Upon information and belief, the defendant, Aaron Caldwell, did on 5/23/2022 commit the offense of Resisting Arrest. The defendant did knowingly and willfully resist arrest after being commanded to exit his vehicle for not providing his identification information. The defendant did have to be removed from the vehicle, once removed the defendant began actively resisting. The defendant was then escorted to the ground, where he refused to place his hands behind his back. The defendant continued to try and flee and conceal his hands under his body. This occurred at York St/Columbia Ave, which is within the city limits of Aiken and is in violation of SC Code of Laws 1976 as amended.
