Counsel for appellant respectfully requests a **fourth and final thirty (30) day extension from September 29, 2022, until October 30, 2023**, in which to serve and file the Initial Brief of Appellant and Designation of Matter in the above-referenced case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a fourth request for an extension. In support of this request, counsel shows:

1. The Initial Brief of Appellant and Designation of Matter in this case are due to be served and filed with the Court today.
2. Counsel for appellant respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the number of extensions


previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.

Counsel filed the petition for writ of certiorari to the Court of Appeals in the case of State v. Sidney Stclair Moorner with the Supreme Court on August 18, 2023. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Jaylen Bell with the Court of Appeals on August 14, 2023. Counsel filed the initial brief of appellant and designation of matter in the case of State v. David Hayden with the Court of Appeals on July 24, 2023. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Quayshaun X. Clark with the Court of Appeals on July 14, 2023.




