Dec 10 2021 I filed for my secone PCR. ~~The State argued~~ The State argued ~~that~~ that my application for my seconed PCR be dismissal for successive/ and or untimely. Judge Steven H. John was not in agreement with the Final Order of Dismissal. Judge John believed the issues I raised in my letter dated 2/24/22

are sufficient to have a evidentiary hearing before a judge. Jan 5th 2023. Before Judge Debra R. McCaslin did not hear my case or my issues raised by Judge John that day. The only thing she said was that she would be making this decision all on her own and it was over. After receiving her order of ~~dismissal~~ dismissal Apr 28. 2023 I wrote to Judge John about what happened in court Jan 5' 2023. That was in July 10th 2023 my letter was forwarded to Chief Administrative Judge William H. Seals and to the Attorney General's office.
