

NOTICE OF APPEAL

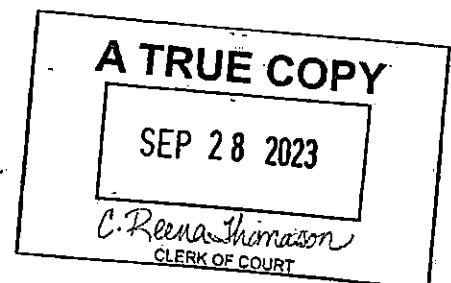


