

Upon reviewing your notice of appeal, the following deficiencies have been noted under the South Carolina Appellate Court Rules (SCACR), and any deficiency must be corrected within ten (10) days of the date of this letter or this matter will be dismissed:

- The notice of appeal is not accompanied by the full and complete order(s) and/or judgment(s) challenged on appeal.
- The required filing fee has not been submitted. The correct filing fee is \$250.00.
- A proof of service has not been provided. You must serve and file a proof of service substantially in the format shown by Form 7 in Appendix C to part II of the SCACR.
- You must provide an amended notice of appeal that is substantially in the format shown by Form 1 in Appendix C to part II of the SCACR. The amended notice of appeal must include the following information: 1) the name of the court, judge, and county from which the appeal is taken 2) the docket number of the case in the lower court 3) the date of the order, judgement, or sentence from which the appeal is taken; and a statement of

when the appealing party received notice of the order or judgement from which the appeal is taken 4) the name of the party taking the appeal 5) the names and mailing addressed of all attorneys of record and the names of the party or parties represented by each.

- Proof of filing upon the clerk of the lower court must be provided pursuant to Rule 203(d), SCACR.
