Mr. Heyward:

Court Administration has forwarded me your request for a transcript of a hearing held with a digital court reporter before The Honorable Maite Murphy. I have reviewed the records and estimate the transcript will be 15 pages.

Payment is required by cashier's check or US Postal money order before I will begin work on the transcript. The time I have to complete the transcript, as outlined below, will begin upon receipt of payment. If payment arrives at my post office box on a day that I am on leave, my time will start on the date I return.

There is an additional charge of \$59.65 for printing and shipping the hard copy of the transcript.

The cost for a regular transcript (60 days) is \$4.25 per page, for a total including printing and shipping of \$123.40.

The cost for an expedited transcript (7 days) is \$5.00 per page, for a total including printing and shipping of \$134.65.

The cost for an overnight transcript is \$6.00 per page, for a total including printing and shipping of \$149.65.

The cost for a same-day transcript is \$7.00 per page, for a total including printing and shipping of \$164.65.
