**NOTICE OF APPEAL  
AND  
REQUEST FOR EXPEDITED REVIEW**

John Thomas Burger appeals the Order of the Honorable Grace G. Knie, signed and filed on October 3, 2023, and attached hereto as Exhibit A. Appellant received notice of this Order on October 3, 2023. Appellant further requests an expedited review of this appeal.

The Order being appealed was issued pursuant to the Uniform Act to Secure the Attendance of Witnesses from Without a State in a Criminal Proceeding, as adopted by this State and codified at S.C. Code Ann. 19-9-10 to 19-9-130 (1976). In South Carolina, proceedings to summon a witness under the Act are civil proceedings and an order compelling the attendance of a witness out of state is a final order and immediately appealable. *See State of Georgia v. Meadows*, 2022 WL 17335653, at \*1 (S.C. 2022). The same is true for other states adopting the Act, including

New York – the state seeking Mr. Burger’s testimony. *See, e.g., In re Issuance of Summons Compelling Essential Witness to Appear and Testify in the State of Minnesota*, 908 N.W.2d 160, 165 (2018)(citing *Codey ex rel. State of New Jersey v. Capital Cities, American Broadcasting Corp.*, 82 N.Y.2d, 521, 605 N.Y.S.2d 661, 626 N.E.2d, 636, 640 (1993)).

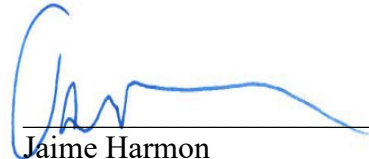
