NOTICE OF APPEAL

John Alexander Webb appeals the conviction and sentence in the above-captioned case.

The sentence was imposed by the Honorable Alexander Macauley on April 23, 2019. An Order granting Defendant's post trial Motion for Judgment in Arrest of Verdict was signed by the Honorable Alexander Macauley on October 18, 2019, and an Order denying the State's Motion to Reconsider was signed by the Honorable Alexander Macauley on December 20, 2019 and filed with the Horry County Clerk of Court on December 24, 2019.

The State filed and served a Notice of Appeal on January 15, 2020. Respondent's Request to File Notice of Cross Appeal Out of Time was denied by this Court. On February 15, 2023, this Court reversed the trial court's grant of Defendant's Motion in Arrest of Judgment and remanded this case for consideration of Defendant's Motion for a New Trial, which was denied by the Honorable Benjamin H. Culbertson on August 10, 2023. Motion to Reconsider was heard on September 21, 2023, and denied on September 27, 2023.
