NOTICE OF APPEAL

Phillip Lee McMorris appeals his conviction and sentence in this case. The sentence was imposed by the Honorable Daniell Dewitt Hall on September 26, 2023. The Appellant pled under North Carolina vs. Alford, 400 U.S. 25 (1970), to Criminal Sexual Conduct with a Minor, Second Degree (§16-03-0655(B)(1)), Carrying Or Displaying Firearms In Public Building (§16-23-0420), Contributing to the Delinquency of a Minor (§16-17-0490). Appellant received a sentence of ten (10) years for the Criminal Sexual Conduct with a Minor, Second Degree; five (5) years for the Carrying Or Displaying Firearms In Public Buildings; and three (3) years for the Contributing to the Delinquency of a Minor. All sentences run concurrent to the others. Phillip Lee McMorris was given credit for time served beginning on May 19, 2022.


