**APPELLANT'S SECOND MOTION FOR FIFTEEN DAY EXTENSION TO FILE
REPLY OR OTHERWISE RESPOND TO RESPONDENT'S INITIAL BRIEF FILINGS**

Appellant respectfully moves for a second fifteen day extension to file a Reply Brief or otherwise respond to Respondent's Initial Brief and Designation of Matter filing. Appellant requests the extension to November 1, 2023.

Appellant will not seek an additional extension outside of truly extreme circumstances, and Appellant greatly appreciates this Court's continued indulgence with respect to his psychiatric disabilities and need for additional time for complex filings.
