Dear Clerk,

On October 17, 2023, I received an email from Denesha M. Staley stating that the Court had not received any updated information on a second extension of time to produce the transcript for this appeal and also that the Court had not received Appellant's Initial Brief.

I was concerned about having not received the transcript by the expiration of Ms. Smith's (the Court reporter) first extension of time to produce the transcript. So I gave her the required 10 days time and then attempted to contact the Office of Court Administration to find out how I was suppose to handle this situation since the Rules are unclear.

I found that Tammie Holmes of the Office of Court Administration was the proper person to make an inquiry. So I emailed her asking what I was suppose to do in this case. A copy of her response to my email, is attached hereto. In her response she told me that Ms. Smith had indeed received a second extension order to produce the transcript. Neither Court Administration nor Ms. Smith communicated the fact of a second extension order to me or to the Court. I was under the impression that Ms. Smith was required to communicate that information to the parties and the Court of Appeals. I must have misunderstood whose responsibility that was.

I received the transcript from Ms. Smith on October 3, 2023. By my calculations Appellant's Initial Brief is due on or before November 2, 2023.

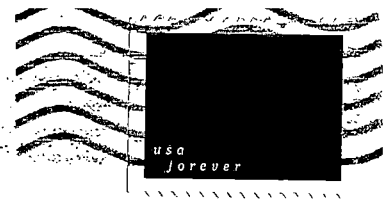
