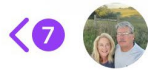

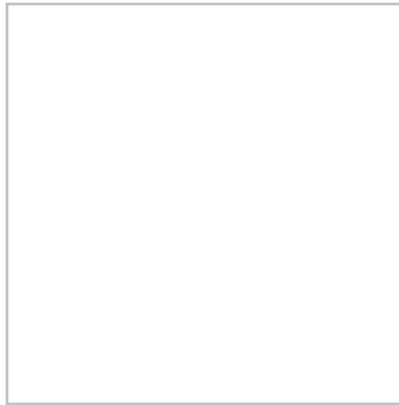

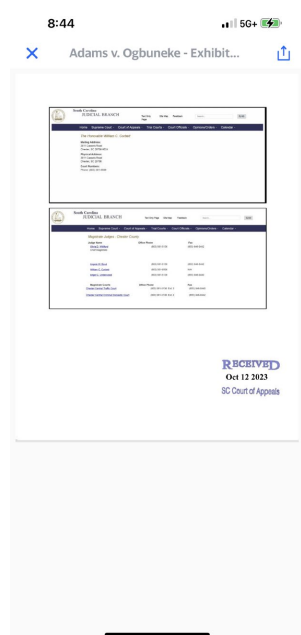
I did not tell the judicial branch what to put down as my address and they decided to put down castles Road. I don't live there nor have I ever been to that address.
