**APPELLANT’S MOTION FOR EXTENSION OF TIME TO FILE AND
SERVE ITS INITIAL REPLY BRIEF AND DESIGNATION OF MATTER**

AND NOW COMES Appellant Mariner’s Cay Racquet & Yacht Club Homeowners’ Association, Inc., (“Appellant”), by and through its undersigned counsel, pursuant to Rule 263(b), SCACR, and moves for an extension of twenty (20) days to file and serve its Initial Reply Brief and Designation of Matter for Inclusion in the Record on Appeal.

1. On October 18, 2023, Respondents served their Initial Brief of Respondents and Designation of Matter.
