

Dear Appellant Court,

This Letter is in regards to that Letter dated October 17, 2023 from the Supreme Court stating "Order of Transcripts". The transcripts are crucial for the proper and timely proceedings of the case, and their absence has caused significant delays and impediments to the administration of justice. The case in question bears the same case caption and case number, and it has come to our attention that there are two different case dockets associated with this particular case. These case dockets, however, exhibit varying actions and proceedings. This discrepancy has created confusion and hindered the process of obtaining the necessary transcripts for the case. On October 17, 2023, an email was sent to the Court reporter of the Lower Courts requesting the transcripts. We have made diligent efforts to contact the Court reporter and have sought clarification regarding the case dockets and the transcripts. Unfortunately, we have not received any response from the Court reporter as of the date of this letter, which is October 23, 2023. Given the urgency of the matter and the impact it has on the administration of justice, we kindly request the intervention of the Higher Court in expediting the resolution of this issue, being that the Supreme Court are in need of the transcripts.

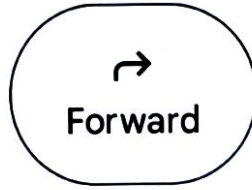
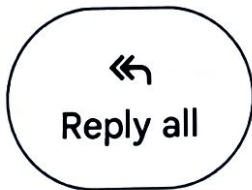
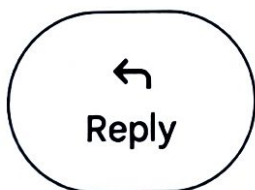
