**APPELLANTS' RESPONSE TO RESPONDENTS'
MOTION FOR EXTENSION OF TIME**

The undersigned counsel for Appellants is in receipt of Respondents' Motion for Extension of Time dated October 18, 2023. On August 14, counsel for Respondents filed a first request for extension, requesting an additional thirty (30) days for the filing of their brief. However, the deadline included within this motion was actually for forty (40) days. On August 17, 2023, this Court granted Respondents' first request for an extension and provided Respondents with a forty (40) day extension, thereby making the deadline October 20, 2023. Appellants' counsel was not consulted on this first request for extension, but Appellants did not object to this request. Appellants were further not consulted on Respondents' request for a second thirty day extension of time to file their brief, which would make the deadline for this brief November 20, 2023.

Appellants do not object to this second request for extension of time. However, given that the initial request provided was actually for forty rather than thirty days, Appellants would respectfully request this Court provide Respondents with only an additional twenty (20) day extension for this second request, for a total extension of sixty (60) days. This would have Respondents' initial brief be due on or before November 9, 2023.

Appellants, however, do not believe any further delay is necessary. Therefore, Appellants would further respectfully request that no further extensions be granted to Respondents for the filing of the Initial Respondents' Brief without good cause shown.
