Additionally, On Tuesday, June 4, 2013, counsel had an oral argument in the case of State v. Jerome Watson. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Michael Wilson Pearson on Tuesday, May 28, 2013. Counsel filed the brief of petitioner in the case of State v. Eric Dantzler on Monday, May 13, 2013. On Wednesday, May 8, 2013, counsel had an oral argument in the case of State v. Antwan McMillan. On Monday, May 6, 2013, counsel had an oral argument in the case of State v. Travell Hill.




