Thank you for your correspondence dated October 24, 2023 and responds as follows:

1. The attorneys have not made a notice of appearance on this case as required by the rules of civil procedure and the rules of appellate procedure. All parties need to comply with the rules of appellate procedure in all proceedings.
2. I will not be submitting a transcript of any kind, because this is state case was moved to federal court by the defendants on this case under 28 USC 1441 and it has not been **REMANDED** back to state court jurisdiction for Marlboro County and Marlboro County has failed to show that they had jurisdiction to act and a court must have jurisdiction over the matters before they can determine the merits of the case.
3. This federal case 4:22-cv-639-TLW-TER is on appeal before the 4th Circuit in Richmond Virginia as these defendants do not have a warrant from Georgia as they have claimed for the past two years and did not have jurisdiction to act.
4. I do not need consent from any of the defendants in South Carolina or their attorneys because they do not have a warrant from Georgia and did not have jurisdiction to act under 28 USC 1441 to issue orders a state case that was moved under federal jurisdiction and dismissed without prejudice under federal jurisdiction and is currently on appeal in federal court under 23-6712.
