This email is being sent regarding the 20-day letter for Trevon Roberts. Our Investigator attempted to hand deliver the 20-day letter/appeal packet on October 25, 2023, to the client in person while he was still incarcerated at the Barnwell County Detention Center. Mr. Roberts reviewed all paperwork that was in the envelope twice in the presence of the Investigator and refused to accept or sign for the packet. The 20-day letter/appeal packet was then mailed to Mr. Roberts at the Barnwell County Detention Center in an attempt to deliver the appeal paperwork before he was transferred to the South Carolina Department of Corrections. Unfortunately, the packet was returned to our office today since Mr. Roberts was transferred to SCDC prior to the packet arriving. The 20-day letter/appeal packet along with a new cover letter was mailed to Mr. Roberts at SCDC today, November 9, 2023. Our office wanted to make you aware of this situation. 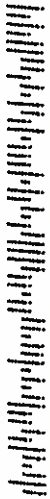
