
NOTICE OF APPEAL

Kimpson, Administrative Law Judge, dated and filed August 7, 2023 ("Final Order") and appeals the denial of MUSC's Motion to Reconsider filed on August 17, 2023, responded to by Trident Medical Center, LLC, d/b/a/ Summerville Medical Center on September 5 and 12, 2023. A copy of the Final Order appealed from is attached as **Exhibit 1** to this notice. There is not a written order denying MUSC's Motion to Reconsider, as MUSC's motion was deemed denied pursuant Administrative Law Court Rule 29.D.(2).


