




Attached please find for filing my Motion for Leave of Court to Withdraw as Counsel in the above captioned matter as required by Rule 30(c), RLDE.

It is possible that some of my clients have actually hired another attorney or obtained court appointed counsel. However, I am unaware of the client in the above referenced matter having done so.

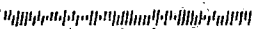
