MOTION FOR AN EXTENSION OF TIME
TO FILE THE PETITION FOR WRIT OF CERTIORARI
AND APPENDIX

Goodwin, respectfully requests an extension of thirty (30) days from November 15, 2023, until December 15, 2023, in which to serve and file the Petition for Writ of Certiorari and Appendix in this case. number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.



Counsel filed the Anders Brief of Appellant, Designation of Matter and Record on Appeal in the case of The State v. Rishard Lewis Geter with the Court of Appeals on September 22, 2023. Counsel filed the Petition for Writ of Certiorari and Appendix in the case of Scott Richard Rowan v. The State with the Supreme Court on September 18, 2023. Counsel filed the Anders Brief of Appellant, Designation of Matter and Record on Appeal in the case of The State v. Preston Hancock with the Court of Appeals on September 15, 2023. Counsel filed the Petition for Writ of Certiorari and Appendix in the case of Derrick Miller v. The State with the Supreme Court on September 6, 2023.

4. Counsel makes this request in good faith and not for purpose of delay.


