Thank you very much for bearing with me. I am not a counsel but an injured claimant trying to seek some justice for what Commissioner Huffstetler and Attorney Michael E. Chase deliberately did to me and my claims.

I copied the diagram of the Court procedures off of the website but it is confusing to me. I sent you a letter dated May 13, 2013, and some e-mail concerning the transcript and that it would not be ready for about 4-6 weeks. I was waiting until I heard something from the court reporter since she goes to different counties to court. I didn't know that I had to ask for an extension from the court for the court reporter since I sent you the letter informing you of the time constraint.
