
1. The undersigned has received the transcript in this matter. According to my calculations, the Appellant's initial brief is due on July 20, 2013. As that day is a Saturday, Appellant's initial brief would be due on July 22, 2013.
2. Upon review of the transcript and filed pleadings, and as the undersigned was near completion of the Appellant's initial brief, I learned of an issue that I feel I must present to the Edgefield County Council for their consideration in executive session and possible vote upon in open session. 3. Although the Appellant is the Edgefield County Assessor, Edgefield County Council must approve any appellate legal action taken on behalf of the County or one of its employees in their official

capacity. The Edgefield County Assessor is not an elected official but rather is appointed by the County Administrator.

4. The Edgefield County Council next meets at its regularly scheduled meeting on Tuesday, August 6, 2013.

WHEREFORE, Appellant respectfully requests an extension until August 19, 2013, to file its initial brief. The Appellant has not previously requested any extensions in this matter.
