**MOTION FOR EXTENSION OF TIME TO FILE
APPELLANTS' INITIAL BRIEF AND DESIGNATION OF MATTER**

Campbell Teague, LLC; George A. Campbell, Jr.; Elizabeth Teague; Emily O'Brian; Molly Cash; and Beau Brogdon (collectively, "Appellants") respectfully move for an extension of time up to and including **January 14, 2024** to file their initial brief and designation of matter to the record on appeal. *See* Rule 263(b), SCACR. This motion is made on the grounds that, due to the undersigned counsel's case schedule and work load, the upcoming holiday season, and the unavailability of a transcript of the lower court proceedings, additional time is needed to prepare and file the initial brief and designation of matter. This is Appellants' first request for an extension. This motion is made in good faith and not for purposes of delay.




