MOTION FOR AN EXTENSION TO SERVE AND FILE
THE PETITION FOR WRIT OF CERTIORARI
AND APPENDIX

Counsel for Anthony Neil Briggs respectfully requests a **final thirty (30) day extension, from November 17, 2023 until December 18, 2023**, in which to serve and file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The Petition for Writ of Certiorari and Appendix are due to be served and filed with the Court today.
2. Counsel for Anthony Neil Briggs respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the

number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.



Counsel filed the Return to Petition for Writ of Certiorari in the case of William Oliver Aguilar Pineda v. State with the Supreme Court on November 3, 2023. Counsel filed the Petition for Writ of Certiorari and Appendix in the case of Brittany Pearson v. State with the Supreme Court on October 27, 2023. Counsel filed the Anders Brief of Appellant and Designation of Matter in the case of The State v. Henry Wayne Parker with the Court of Appeals on October 11, 2023. From October 9, 2023 through October 11, 2023, counsel attended the Annual Public Defender Conference. Counsel filed the Petition for Writ of Certiorari, Brief of Appellant Pursuant to White v. State, and the Appendix in the case of Brian Foster v. State with the Supreme Court on October 3, 2023.

4. Counsel makes this request in good faith and not for purpose of delay.


