Appellant's SUPPLEMENT TO HER 16 NOVEMBER 2023 EMERGENCY MOTIONS NOT Scanned and Uploaded to C-Track by this Court's Clerk's Staff until 21 November 2023 and erroneously at that.

First cited are the errors seen in the scanning of Dr. Assa'ad-Faltas' papers hand-delivered to this Court's Clerk's office on 16 November 2023 but **not uploaded to/visible on C-Track until** late 21 November 2021 morning:

- Pages 26, 43, and 462 of the Amended UNBOUND Record on Appeal ("RoA") are missing. **They were delivered to the Clerk's office along with all other amended RoA pages on 16 November 2023.**
- The Certificate of Relevance and Completion and Certificate of Service **of the UNBOUND (amended) RoA** is *filed as if it were* the Certificate of Service of the 16 November 2023 EMERGENCY MOTIONS.

Second cited is the persistent failure to acknowledge receipt **of the bound copies of the amended RoA and of Appellant's Final Brief and Final Reply Brief.**

Third cited is the persistent failure to post **the unbound copy of Appellant's Final Reply Brief** as such; instead, it is curiously *and erroneously* attached to Dr. Assa'ad-Faltas' 6 November 2023 MOTION to defer filing the *bound* copy of RoA, which motion is mistitled on C-Track and has become moot in any event.


Reiterated is Dr. Assa'ad-Faltas' *certainty* of her delivery of complete correct copies of the erroneously-scanned documents and her having *attempted* to identify them correctly to the clerical receiving staff who were, instead, focused on *arrogantly and rudely* emphasizing to Dr. Assa'ad-Faltas that she is not allowed to talk them!?!

Reiterated again is Dr. Assa'ad-Faltas' *previously-proposed solution*: allow her **one filing by email of the digital originals of the papers already delivered to this Court but which this Court's Clerk seems unable and/or unwilling to scan and post correctly** *apparently to bait* Dr. Assa'ad-Faltas into calling and incurring contempt.

Reiterated finally

- Dr. Assa'ad-Faltas has too much class (not money) to take that bait or any other bait to be contrived;
- Judges' duties are primarily **to advance the law**. When this Court uncritically obeys John Williamson Kittredge "right or wrong," **it retards the law** instead of advancing it; and
- the *only* reason to *selectively* deny Dr. Assa'ad-Faltas filing by email is to pander to John Kittredge's arbitrary and discriminatory abuses of position which are taking SC's judicial system into nationwide, if not world-wide, disrepute, if not ridicule. **Without this Court's exercise of independent judgment, no foreign-born litigant can have any expectations of, or confidence in, equal treatment in SC's courts at any level.**

WHEREFORE, this supplement and the antecedent emergency motions should be open-mindedly considered and granted as hereby sincerely reiterated and supplemented on 21 November 2023.
