PLEASE make sure you read the letter sent a couple of days ago and the documents attached. The other one mentioned will be sent today. Mr. Dudek.. I truly need and appreciate your help. Thank you. I believe anyone in my situation would have been stressed, confused and intimidated by such actions as Lir put me through. He really needs help with his drinking or others will be hurt both in and out of the courtroom.

Attached are 3 major documents attached at bottom... things my atty never told the judge, solicitor, nor allowed me to share. Lir refused to let me tell the truth in court. I ask you please request court cameras and see things took place just as my letter sent yesterday explained. Also, the day I requested a jury trial. Lir did not show up but called and threatened me by phone that I either make it to courthouse and request a jury trial or go back to jail for missing court earlier that morning. Of course he did not even come. (He never even let me know I had court til he told me I missed it that morning, then he called me.

Please see attached documentation of the Enterprise document my attorney told me would have the case dismissed on Feb. 14, 2023. A copy of the document from Enterprise on July 9, 2020 where Mike Mintz tried to rent me a vehicle,..note it was One WaY... but he was denied due to having no credit card. Mike saw the high cost though and later offered (I did not ask) to rent me his extra vehicle. I paid him \$1000 and we had a verbal agreement for me to leave vehicle at a designated rest area. Which I Did! He said he may go with me.. I waited about 4 days before leaving. But he used money for drugs and he did not go and I know now he never in to go with me. But knew the day and time I left. He handed me the keys. He is on recording stating he talked to me at my motel the day I was going to leave. He never intended to go. But thought I'd leave town that day. Due to a lot of research I found out Mike Mintz, reported the vehicle as stolen to his auto insurance company that SAME day he took me to Enterprise July 9,2020. That was a Shock to me!! I didn't even leave his yard until 3 or 4 days later because I thot he might go with me. So it was a set up from the beginning. The report of stolen vehicl is also attached and was from NMVTIS, so it is officially.He was denied any money..he willingly gave me the keys and told me where to leave vehicle

Following that..for the next 8 months Mike never said a single word until he saw I was arrested for a traffic violation in another county .. he then decided to try again to collect money...8 months later he filed charges against me. I was SHOCKED as I thought he was my friend. Of course you'll see he changed it now to breach of (Oral) agreement. but the fact he reported it stolen the first day..4 days before I even left town and his house, shows the intent

was to collect. When he couldn't do so from his auto insurance..some 8 months later he tries another route. I attached a zoomed in image so you can see reported stolen on July 9, 2020..da we went to Enterprise.

IN another email I'll also send the name of the gps account that tracked his vehicle. It's in his sisters name, and Mike said so.. all he had to do was track the vehicle.. which can still easily be done. I have a copy of that company and the account number. I will send that in the morning.. along with the only paper they gave me in court as it was not the same as what you mailed me a copy of. Also an attorney I tried to talk to but could not afford before going to court when Lir was making threats I better bring him more money..

Everything will be in tby the end of the day (Friday) I have to appeal. if anyone is guilty it is Mike Mintz for trying to pull a scam. Sadly I had no representation. My attorney lost his focus and ability when he started drinking so heavily. But he used scare tactics.. Who else has he hurt like this? As I said I have a sworn affidavit from the man that lived with Mike and witnessed the calls telling Mike to come get his truck. I left it exactly where Mike told me to leave it. that's why the Enterprise says ONE Way..

Court of Appeals has been such a big help. Thank you very much. I just want my life back please. I'm a good man. I don't deserve this. Thank you.
