I am fighting for my life and tired, struggling and just very stressed.. thank you for your help. this is also very important as vehicle easily tracked. But Never got to share anything. See attachments. I tried to change to pdf files. I forgot that's the format you request.

Mike Mintz told me he has a tracking subscription which is in his sister's name. See attached... This is showing a different vehicle. But a simple reactivation if this account will show the past history and whereabouts also of Mikes truck which is also included. Once subscription is reactivated....It should show dates and a history of where his truck was left (at the rest area where Mike Mintz verbally told me to lock it up and park it). It should also show where it was either towed or taken from there.

Also the tenant/ witness who lived with Mike for a long while was present when Mike received a phone call to come pick up his truck in July 2020. That's when Mike Mintz hung the phone up and said "I'm not going to go get that F\*\*king truck". He could have gotten his vehicle at any time, but Mike knew he had secretly reported it as stolen to his insurance company and was hoping to get out from under payments. His sister is pretty well off and Mike said she helped pay a lot of his bills. I don't know how much of the truth she knows.

But Mike took that \$1,000. from me, purchased drugs and shut up in his room doing drugs for several days after we left Enterprise that day July 8, 2020... He verbally told me to take and use his vehicle and being I planned to not return to SC, exactly where to leave it parked. Mike even also said he had a friend who could go with him later, do some fishing, then take him to his vehicle... But all that, I sadly learned was an act ! I thot Mike was going with me, not realizing at the time, he was just saying that. I had NO IDEA he'd reported this truck stolen the same day I paid him... I only found out this information after he filed this bogus case and I tried to track the history through an online program.

Mike had to assume I'd leave that day, not wait several more days for him to be ready to ride with me. It was a set up.

As stated, a long while back, Mike made a comment that he needed that damn vehicle to conveniently disappear. But I didn't pay any attention to that as I thought he was joking around. I had no idea he would really do something like that...

Obviously, he was unable to collect from Insurance after reporting it stolen on July 9, 2020. As he took the \$1,000 and gave me the keys, and he knew the time and day I left. I have him somewhere on a recording saying he talked to me the morning I left and we were on great terms I thought.

As I said, all he has to do is reactivate the subscription below which also covers the history tracking of his truck.

Also the attached paper (it's pink) is the only thing the courts gave me after I went before the court in Feb. 14, 2023. They told me to wait in my car and they'd bring it to me. I was in a state of shock as to what had just happened in court. I was sitting with my friend who went to court with me and we were both in tears

The lady came and gave me this paper. They seemed shocked and a worker said they'd never seen anything like this. They said they'd pray for me. Note my pink paper and the papers you sent me are not the same. But even more charges listed. even in Lirs Exparte. Like I said Mike tried first to collect that first day by saying it was Stolen. But when he couldn't collect they changed it all around

And this was an oral friendly agreement supposedly between 2 friends. This is just wrong and I never was allowed to share and my attorney purposely went from the charges being dropped to pushing me.rushing me and lying to me ..leading to this outrageous sentence...

I know the Court of Appeals has copies of at least 2 of Lir's arrests, and police reports, but I wasn't sure if you had it also Mr. Dudek. This is just one of at least 3 arrests within months and 2 were a couple weeks prior to my court on Feb. 14, 2023 where Lir lied to me, pressured and intimidated me. He'd been sending me threatening texts for 2 to 4 weeks about money. Yet I also have a text saying I paid him \$5000 in full for prior case where he also did something similar, costing me 7 months of incarceration. (as with this case, I was innocent and Lir did this to me at the last minute with scare tactics).

Plus I have the text from Lir where I sent him \$400., plus a receipt he wrote out and signed for this case for \$1500. plus 6 weeks later I sent him another cash app totalling at least 1500... I also have a copy of a subscription that only needs to be reactivated (Mike Mintz told me this and I have a copy of the account number and information to easily track the vehicle).

(I sent copies of some of my receipts, texts and GPS info just a few minutes ago.)

You can see Lir has serious issues with at least alcohol, maybe more..., both times he drove while in this state of mind and altered condition. He was not prepared to represent anyone as he should.

This attached incident was just 2 weeks before my court (Feb. 14, 2023) where Lir tried to mess my entire life up, instead of defend me. The other police report I sent to court of appeals with Lir leaving the scene of an accident, driving drunk.....they were able to locate him at home was a more in-depth report showing that Lir was so heavily intoxicated he had to lean on a wall to even stand.

He appears to have gained a lot of weight since I first hired him. In addition to him bringing harm to his clients for crimes they did not do, losing records, and using fear tactics to force plea deals and bleed clients for more money....Lir's actions of drinking heavily and whatever else he may be doing could cause a car accident and could cost someone to be injured or killed.

The value of vehicle is much less than what they put to begin with. But I did nothing wrong and Mike planned this. I was so SHOCKED when I found out he reported it stolen to insurance the very same day me and him were at Enterprise as good friends. That didn't work out for him because he gave me the keys, knew where I was going, told me good-bye which was several days after we were at Enterprise. .... Then some 8 months later.. he tries this again. This is just crazy. He changed the charge every time one didn't work out.. He has NO IDEA I found out he reported it stolen the day we were at Enterprise.. I couldn't believe that. But I sent you documentation of that as well in a separate email.

I just need you to see I truly do deserve this appeal and I believe once the solicitor actually sees all this, he would do the right thing to have this case and sentence dropped.





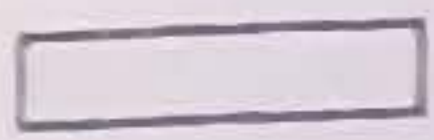

**Narrative**

On 01/21/2023 I Deputy Navarreesquivel responded to I/L in reference to a suspicious person. When I arrived I made contact with Lir Derieg (offender). Lir was sitting at a table inside the I/L directly next to the cash register, where the complainant Alaysha Nicholson was standing. Alaysha stated Lir got out of his vehicle and walked inside and sat down. Alaysha stated he sat there for almost an hour before she called R/O. When I attempted to speak to Lir, Lir looked at me with a blank face and appeared to struggle keeping his eyes open. I attempted to come closer to Lir to speak louder so he could hear me, to which point I could smell a strong odor of alcohol emitting from Lir. I attempted a final time to ask Lir what he was doing and how many alcoholic beverages he consumed today, to which point Lir couldn't speak and struggled to keep his eyes open still. I then arrested Lir for Public Disorderly Conduct. Upon searching Lir incident to arrest, I found his keys in his pocket, which came back to the black jeep that was on and running in the parking space next to my patrol car. Deputy Hernandez completed a tow sheet and had the vehicle towed by All Around Towing while I transported Lir to ACDC. Lir was issued UTT 8102P0883868 for Public Disorderly Conduct which is in violation of SC Code Of Laws, As Amended. Lir was then transferred to ARMC for a medical clearance. Once cleared, Lir was transferred back to ACDC where he was processed. I have no further.
